1 Completing the additional deposit form

All Applicants must complete the following sections of the additional deposit form:

2 Payment

The following forms of payment are acceptable:

Cheque

Your cheque must be:

- made out to "AXA Australia – name of the fund
- crossed "Not Negotiable", and
- attached to the completed additional deposit form.

Direct deposit / Telegraphic Transfer

If you select this option you must:

- arrange to have funds deposited / transferred into the relevant Westpac Bank Account; and
- fax a copy of your completed additional deposit form to us at (03) 9617 2329 before 1pm Melbourne time on a Melbourne business day

All applications must be denominated in Australian dollars.

We cannot accept cash deposits.

3 Investor signature

Individuals

The additional deposit form must be signed personally or under a power of attorney. A certified copy of the power of attorney (including confirmation from the attorney that it has not been revoked) must be provided.

Joint applicants

Joint applicants must each provide their full names and sign the additional deposit form. All correspondence about the investment (including the payment of distributions and withdrawals) will be sent to the first named applicant.

If you selected the option in the original application form authorising any applicant to sign on behalf of the other joint applicants then only one joint applicant need sign and complete the additional deposit form.

Joint applicants are treated as joint tenants. This means that if one of the joint applicants dies, only the other joint applicants will be recognised as having any claim to the investment.

Companies

A company must sign the additional deposit form in one of the following ways:

- 2 directors; or
- 1 director and 1 secretary; or
- the sole director who is also the sole secretary; or
- otherwise in accordance with the company's constitution (and in this case a certified copy of the relevant sections of the company's constitution must be provided).
